
# White Paper **Crypto Beauties** Where beauty meets blockchain

- 30%: Reserved for the initial decentralized exchange listing (IDO) to allow wider accessibility.

### **Token Utility**

- **Governance:** Token holders that participate in the staking activity will have voting rights in the DAO, allowing them to participate in decision-making processes.
- **Staking Rewards:** Users can stake their tokens to earn rewards in the form of additional tokens or a share of platform revenue.
- Access to Exclusive Content: Token holders may gain access to exclusive content or merchandise. We may also offer an all-expenses-paid trip to select token holders, granting them the opportunity to visit our trading houses and meet our Beauties in person.

### **Tokenomics Summary**
